Fairburn Youth Association (FYA) is a volunteer, parent-led booster club with a mission to support the students and teachers of Fairburn Avenue Elementary School. Consistent with past years, the grant would be used to subsidize our payment to PlanetBravo Technology Education. PlanetBravo teaches computer literacy to students in grades TK-5 through weekly instruction in the school's computer lab. Each grade level has thematic lessons that tie into national technology standards and Common Core academic standards. Lessons for our youngest students are based on the theme of coordination (mousing, key-finding, and basic understanding of the OS enviroment through arts, word processing and gaming). Themes for older students include creativity, presentation, and communication, and incorporate coding skills, responsible internet research, and video production.

PlanetBravo instruction gives every child a chance to learn necessary computer skills -- whether or not they have access to a computer at home -- and prepares them for secondary schools and beyond. Developing a population with computer literacy and computer science/infomatics expertise is critical to the success of our economy.
