Project Description: Application for seven unit apartment over subterranean garage with 16 parking stalls and 9 bicycle rack. due to passing storm drain under property, requesting height increase from 45' to 49' and setbacks reduction from 15' to 12' because of required 13' HWD.

Matthew Raanan and Ryan Rifkin presented the project.

Connie Boukidis moved, seconded by Dr. Jerry Brown, and carried unanimously:

“ WWNC LUPC recommends to the WWNC BOD to support the project with a note to the Design Review Board that the required placement of the handicap lift be aesthetically pleasing. Also that owners present the project to the Westwood Homeowners Association for their support. The board also recommends converting one unit to affordable housing.”

“WWNC LUPC recommends to the WWNC BOD to support the project as presented with the following conditions: Regarding the roof top; any barriers for safety from the roof’s edge setbacks be reconfigured to increase the safety of the roof deck; example, by increasing the height of the railing. WWNC BOD recommends that at least one unit be converted to affordable housing.”

Marcello Robinson moved, seconded by Ann Hayman, and carried unanimously:

“WWNC LUPC recommends the WWNC BOD not support the project as presented due to the not aesthetically pleasing appearance of the antennas on the roof top viewable from Westwood Blvd and Lindbrook Ave, which would add an additional not aesthetically pleasing 3rd story. We recommend T-Mobile continue to look for a more suitable property for their antennas or find a way to attach the antennas to the existing property that cannot be seen from the street and would not add an additional story to the building.“

Project Description: CUP Renewal re sale and dispensing full line of alcoholic beverages for onsite consumption at existing 7,458 sf restaurant with 181 indoor seats and 29 outdoor seats on 362 sf patio, operating from 7 am to 2 am daily.

PROPOSED MOTION:

The WWNC supports:

Condition 21 as follows: "A maximum of three coin operated game machines are allowed. Pool tables or similar game activities or equipment shall not be permitted.

Official California State lottery games and machines are allowed.”

Condition 22 to remain the same, as follows: "Pool tables, billiard tables, and Adult Entertainment uses [Municipal Code Section 12.70] shall be prohibited. There shall be no disc jockey, topless entertainment, public performances or fashion shows.

Live music/entertainment shall be limited to karaoke after 10 p.m. daily. The karaoke shall be limited to the open dining area and a separate karaoke room shall not be permitted.

The restaurant operation shall keep a record of the karaoke nights, which shall be made available on the site upon request by the Building and Safety, Police and Planning Departments, the Alcoholic Beverages Control and other responsible agencies.

Live music/entertainment and televisions shall not be permitted in the outdoor patio."

Condition 50 is to be removed as requested as long as it conforms to the City of Los Angeles policy.

No vote was taken on this motion.

The meeting was adjourned by unanimous agreement at 5:13 p.m.
